- At a subsequent meeting of the Willacy County Commissioners' Court upon notice thereof, as the County shall determine.

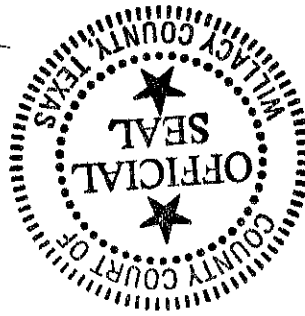
