Chairman Guerra, welcomes the members from The City of Raymondville, Hidalgo County Drainage District No. 1, Delta Lake Irrigation, S & B Infrastructure, LTD and some other members from different entities. Raul E. Sesin, PE, CFM with Hidalgo County Drainage District No. 1 proceeds with a presentation on reference to the Raymondville Drain, Project for Flood Control Projects Impacts.

Mr. Sesin, updates to the Commissioners Court that the Raymondville Drain Project is included on the Texas Multiyear Implementation Plan for the RESTORE ACT for the cleaning of 62.51 miles of existing drain and is likely to receive a grant for approximately \$7.0 million to clean the existing drainage infrastructure. This includes 14.72 miles of channel in Hidalgo County and 47.79 miles of channel in Willacy County.
