Chairman Guerra, continues with discussion on reference to the 2017-2018 Budget Workshop. Discussion continues on reference to the Budget for the following departments:

#### **Constable Precinct 2:**

Commissioner Gonzales, asks Constable Joe Salazar if he knew that Constable Vera had requested Vests, Radars and some Body Cameras. Constable Salazar, states he wasn't aware of it, if possible he would like if he may be given at least two (2). Discussion starts with Constable Precinct 2, Joe Salazar on reference for Advertising to hire two (2) part-time positions from a Grant. Ida Martinez, County Auditor states the Advertising needs to be posted and advertise on the local newspaper. Constable Salazar, states he will start advertising now, so it may be advertise on September 6<sup>th</sup> and the deadline for applications will be September 22<sup>nd</sup>. Account Number- 401-140 Advertising will be coming out from Administration. Account Number- 115 Gas added another \$500.00. Account Number- 192 Community Involvement asking \$400.00 more.

Chairman Guerra, states the Elections Office will be moving where Justice of the Peace Precinct 2 Office was, due to the fact this office is being moved with the other Justice of the Peace Offices. Also, the County will be providing office spaces for the Constables, which previously was occupied by the Elections Office. Although, can't promise/commit to do any remodeling, nor providing computers. Chairman Guerra, says he admires Constable Salazar for looking out for Grants.

Commissioner Guerra, asks Constable Salazar if he may do extra patrolling at the Fred Stone Park-Prier due to graffiti going on, when he gets his extra help. Constable Salazar, says this will be one of his goals.

# Commissioner Oscar De Luna arrives at the meeting at 9:25 a.m.

Chairman Guerra, says for Community Involvement to keep it under Administration maybe will be able to use more than \$1,200.00, but Constable Salazar will need to get on the Agenda for approval through Commissioners Court. Constable Salazar, asks for his request for Community Involvement be removed from his wish list and no other further changes on his Budget.

#### **Hotel and Motel Tax:**

Discussion continues on the new position for the Community Development Specialist paid from Hotel/Motel Tax. Chairman Guerra, asks Mrs. Martinez to put the difference in Account Number- 200 Repairs and Maintenance. The salary for this position will be \$40,000.00. The Chairman, tells Mrs. Martinez to balance out by removing half from Account Number- 192 Community Involvement and half from Account Number- 385 Machinery and Equipment > \$500.00. Account Number- 32 Longevity \$60.00. A draft copy is attach.

### **Elections Department:**

Discussion starts with Mary Hope, Elections Administrator on reference to Account Number- 130 Communication Expense asking for an allowance for the phone service. Chairman Guerra, states that the phone service has to be done, which will not be coming out from Mrs. Hope's Budget, but from a different source. Although, for the mean time to take her old phones with her to her new office. Also, would like a salary raise for herself on her wish list. Mrs. Hope will like to request a salary increase to balance out more less what the other Appointed Positions are making. Although, if that not possible Mrs. Hope, states she is not claiming Insurance from the County; maybe if that can be put into her salary the amount is more less \$4,800.00. Chairman Guerra, states they were considering on the Veteran's Salary, but he is still checking into it. Mrs. Martinez, states it will be an estimated amount of \$7,548.62 for Mrs. Hope's Salary Increase. Commissioner Guerra, states if she is not using that money from her Health Insurance, maybe it should put on her salary. Chairman Guerra, states this is just a wish list, they need to come back and revisit them.

Mrs. Hope, asks the Court if they can provide her with extra help, maybe from one of the other departments helping her out with one of their staff to help out with the Elections. Due to the fact, with the new redistricting they will be needing more help. Since, at one time Mrs. Hope mentions she was willing to lend her Assistant (Laurie) to the County Treasurer's Office.

Chairman Guerra, states maybe they can provide Mrs. Hope with a Temporary Personnel at a salary of \$22,000.00 for four (4) months, which will be up to \$6,400.00 quarterly. Chairman Guerra, suggest Mrs. Hope on reference to the Advertising.

Motion was made by Commissioner Guerra, seconded by Commissioner De Luna for approval to add on Account Number- 30 Temporary Personnel item for the amount of \$6,400.00 for the Elections Administration. Motion was put before the Court by the Chairman. Commissioners Guerra, De Luna and Gonzales voting AYE. NAYS NONE. Motion was declared carried.

Commissioner Gonzales, states the only thing pending on Mrs. Hope's wish list is her salary increase.

#### **Constable Precinct 3:**

Discussion starts with Constable Ben Vera on reference to the Vests, Radars and Body Cameras an estimated total amount of \$27,500.00. If it's divided by the six (6) Constables it will be more less about \$4,500.00 per Constable. Constable Vera, states the priority will be the

Cameras, Radars and then the Body Cameras. Also, Constable Vera states if there will be consideration for the County buying some cameras for inside/outside at the Courtroom, South Side, Lobby Area, Hallway, Prisoner's Entrance and Parking Area. Constable Vera, mentions three (3) different quotes to the Commissioners, which are \$6,500.00, \$8,500.00 and \$10,000.00 they include labor and maintenance. The lowest bid is the company that had done work before to the DA's Office, which is Security National.

Lee Gonzales, Internet Technician states there is a company call Harlingen Alarm, which they provide these services too for the cameras. Constable Vera, says only asking if it may get approve in the budget, so he can start asking for some quotes. Chairman Guerra, says this might get paid from Drug Seizures, but don't know how Mrs. Hinojosa will end up on this Fund. The Chairman, advises it might need to be pulled out from other source of monies, either from Health and Welfare or Machinery and Equipment > \$500.00. Chairman Guerra, states maybe consider two (2) out of the seven (7) cameras based on cost and see how they would work.

Constable Vera, asks about the Constables' Equipment where the monies will be coming out from? Commissioner Gonzales, states maybe will be coming out from Capital Fund, since it's a one-time purchase. Chairman Guerra, states they would need to come back on it and revisit this request.

#### **Administration Office:**

Discussion continues with Chairman Guerra on reference to Awards Program to leave it at \$3,065.00. Account Number- 160 Insurance was \$107,095.00 raise it by 10% increases to \$118,707.00. Mrs. Martinez, states she will need to revisit the Sheriff's Department on reference to the Insurance. Account Number- 180 Contracts and Legal was original budgeted at \$59,760.00/new budget \$38,145.00. Account Number- 192 Community Involvement kept it at \$9,000.00. #### **Health and Welfare:**

Discussion continues with Chairman Guerra on reference to Account Number- 430 Autopsy to keep it at \$16,000.00. Discussion continues with Ida Martinez, County Auditor on reference to \$2,000.00 was for the County Visiting Judges and \$21,200.00 for the County Court Reporters. Chairman Guerra, states the Fire Calls were dropped to \$25/call and was budgeted at \$6,500.00. Although, \$7,000.00 was put for Fire Calls. Also, to follow up with the Fire Chief on reference to the fuel expenses. Discussion continues on Account Number- 200 Repairs and Maintenance increases to \$19,075.00. Account Number- 115 Gas increases to \$15,000.00. Also, for the Community Development Specialist \$32,000.00 was funded from Fund- 40 (80%) and \$8,000.00 was funded from General Fund (20%) totaling a salary of \$40,000.00. A draft copy is attach

Discussion continues with the Commissioners on reference to the problems their having at their dumpsites due to Construction Companies dumping outrageous left over material from construction. The Commissioners would like for the Companies to purchase a Demolition Permit and maybe set a fee or fine for the weight of the material.

Ida Martinez, County Auditor states that she removed the extras from Hotel/Motel Tax to Health and Welfare under Repairs and Maintenance. Hotel/Motel Tax Account Number- 385 Machinery and Equipment > \$500.00 changes to \$15,354.00. Account Number- 200 Repairs and Maintenance changes to \$5,240.00.
